Competition Terms and Conditions

These competition rules shall be binding on you when entering any competition(s) operated by us, our sponsors or any company or website owned or controlled by us from time to time.

In addition to these general competition rules, other specific terms and conditions may also apply to a competition. We will post any such specific competition rules on our website.

You must be over 18 years of age and resident in the UK to enter our competitions.

Members of Burgess Hill Radio and any company associated to the specific competition and their families are not eligible to enter the competition.

Anyone who has won a prize within the last six months on Burgess Hill Radio station valued at £150 or more shall not be eligible to enter the competition, nor shall any member of such person's family nor members of the same household (including, but not limited to, aunts, uncles, cousins, grandparents etc).

Only one entry per person is permitted, unless otherwise stated. Automated entries will be invalidated, including multiple entries from the same IP, email address or telephone number range.

Proof of making a phone call, sending post/e-mail/text is not proof of our receipt of your entry. No responsibility can be accepted for entries that are lost, delayed or damaged.

The closing date is as specified in the relevant competition. This will always be a time and date in the UK. Where a time is not given, the closing time will be 11.59pm (UK time) on the relevant day.

In the case of a prize draw, the first correct entry drawn will be the winner.

Winners will be formally notified (by email or post) within seven days of the closing date. Full details of the prize will be given in writing upon notification. Where we notify a winner by email, we will ask for confirmation of receipt by reply email.

In the case of prizes in the form of free tickets, we will contact the prize winner by phone and prize details shall be as printed on the tickets. Ticket holders shall be bound by the event promoter's terms and conditions together with those set out on the ticket and the rules and regulations of the venue. The judge's decision is final and no correspondence will be entered into.

The prize may not be transferred to any other person.

No cash alternative or alternative prize is available on entrants' request but in the event of the advertised competition prize being unavailable we reserve the right to offer an alternative prize of equal or greater value.

Burgess Hill Radio will not be liable for any damage, loss or disappointment suffered by any person taking part or not being able to take part in a competition.

Competition winners may be required to take part in or co-operate with publicity.

Competition winners agree to keep confidential any knowledge about Burgess Hill Radio and its business and personnel received by them as a result of the competition.

No responsibility is accepted for inaccurate prize details supplied by sponsors.
